A recent paper from the Fordham Institute, *The State Education Agency: At the Helm, Not the Oar*, has evoked considerable commentary about how SEAs can most effectively accomplish their many mandates. Ashley Jochim, a research analyst with the Center on Reinventing Public Education, a BSCP partner, has penned a useful response, titled *To Take the Helm, State Ed Agencies Need a Navigator*. The article examines the challenges that come with contracting work out to other organizations. Ashley comments that, "While the prescription to shrink the size of the SEAs may be an attractive one to those who see these agencies as ineffective, it is at best an incomplete fix. Form, function, and politics matter much more." Through our partnership with CRPE, we will continue to study the issues of SEA performance and productivity and assist states as they seek to leverage their investments in PK-12 education toward greater effect. - ✿ **The Communications Benchmarking Project** is continuing. Because there is little information or research that specifically covers SEA communication strategies, we have found this project to be particularly interesting and exciting. We are in the process of comparing results with recent research of effective communication strategies from organizations outside of the education field. This work is moving forward and will be shared with interested states and RCCs upon completion of the analysis and research, hopefully near the end of June or July.
- ✿ The announcement for [Volume 3](#) of **The SEA of the Future** was sent out in late May. Already, several hundred of you have opened the document. This volume of our flagship publication, entitled Building the Productivity Infrastructure, gives insights from 4 perspectives about how SEAs can organize to promote productivity. As always we are eager for you to read these thought provoking essays and give us your reactions.
- ✿ The **Project Management 101 webinar** was recently held. Participants that were new to the project management process found it to be informative with requests for the webinar and power point to be posted on our website. We are in the process of having the webinar and slides posted on our website, analyzing the surveys from the 22 participants, reviewing their recommendations, and determining the next steps for this project.
- ✿ The **Chief Performance Officer** group is currently prioritizing their “Problems of Practice” discussions and identifying a date for a face to face meeting to be held in San Antonio. RCCs that represent the 8 Chief Performance Officers states are also invited to this face to face meeting.

I hope you find this update of our current work to be useful. As you can see, we are headed into some new and important practice areas, and we are energized by the potential utility of our latest projects. I trust this letter finds you with a little downtime for summer relaxation and time away from your desks enjoying the benefits of the warm sunshine season.
